


Dear Voter:

I am pleased to provide you with information about our Permanent Voting By Mail option. This program is intended to simplify voting for registered voters who wish to receive their ballot by mail on a permanent basis. This is not a one-time ballot request form, but an enrollment in the Permanent Voting By Mail Program. You must be a registered voter in Lake County, Illinois to participate. **Enrollment in this program remains in effect until you provide notification to cancel, or your voter registration becomes inactive.**

To enroll, please complete the form below including each primary and general election in which you wish to vote. Return the signed form to the Lake County Clerk's office address. Prior to each primary election which you select on the enrollment form, we will contact you for your party ballot preference. You will receive an application and ballot for each election you select at the address you provide. If this card is distributed by a candidate or organization, provide their contact information as well.

During the period for voting by mail, you will be able to go to [LakeCountyClerk.info](http://LakeCountyClerk.info) and click on the "Voter Power" link to track the receipt of your voted ballot by the Elections Department.
